# Association of Military Legal Administrators Policy and Procedures

### **POLICY:**

- 1. AMLA will award two academic scholarships, one in each category, of equal value, to qualified applicants in each of the following categories:
  - a. Category I: Eligible spouse or child (17-21) of AMLA Members
  - b. Category II: Eligible non-serving, non-retired Veteran (Non-AMLA affiliated)
- 2. The scholarship awards shall be based upon personal essay. GPA is needed to verify enrollment but is not a determining factor in our scholarship awards. Applicants will need to share within their essay how their educational goal feeds into our organizational values of Teach, Coach, Mentor, and Lead.
- 3. The selection committee will be comprised of AMLA members through a blind screening process.
- 4. The AMLA Treasurer shall issue a check in the full amount of the scholarship awarded payable to the selected recipients.
- **5.** Eligibility is restricted to members of AMLA and/or their dependents for category I. Any veteran that is not currently serving or retired may apply under category II with proof of service. You may apply/join AMLA at <a href="https://www.amla-tcml.org">www.amla-tcml.org</a>

### PROCEDURES:

- 1. Applicants must submit the following material to the committee: completed legible application form; GPA verified by school counselor or unofficial school transcript with GPA listed; personal essay of no more than 500 words.
- 2. The AMLA Scholarship Committee will meet as needed in support of the scholarship program.
- 3. Incomplete or inaccurate applications will not be considered. All submitted materials will become the sole property of AMLA and will be retained for one full year from the date of selection. At the end of the year, all applications and supporting documents will be destroyed.
- 4. This is an essay scholarship, essays submitted will be evaluated according to the scoring rubric provided with the application.
