Chief Warrant Officer Four Vickie A. Slade is a native of Atlanta, Georgia. She graduated from Troy University with a Bachelor's Degree in Business Management. She enlisted in the U.S. Army Reserve in February 1979, prior to her graduation from high school. She joined the U.S. Army Reserve as a Legal Clerk, assigned to the 213th Military Law Center, Chamblee, Georgia. After 18 years of enlisted service, she was appointed Warrant Officer One in the Judge Advocate Branch in March 1997.

Chief Warrant Officer Four Slade served as a legal clerk and court reporter in Chamblee, Georgia and Birmingham, Alabama. She was selected for appointment while assigned to the 81st Regional Support Command, Birmingham, Alabama. After her appointment, she served as a Legal Administrator for the 3d Medical Command, Decatur, Georgia; the 2125th Garrison Support Unit (GSU), Decatur, Georgia. During her tenure with the 2125th GSU, she mobilized to Fort Bragg, North Carolina, in support of the Global War on Terrorism. Chief Warrant Officer Four Slade was assessed onto Active Duty in July 2004. Upon her accession, she served as a Legal Administrator for the Center for Law and Military Operations, The Judge Advocate General's Legal Center and School; U.S. Army North, Fort Sam Houston, Texas; North Atlantic Treaty Organization Training Mission-Afghanistan-Combined Security Transition-Command-Afghanistan, Kabul; Maneuver Center of Excellence, Fort Benning, Georgia. She also served as the Legal Engagements Warrant Officer, U.S. Africa Command, Stuttgart, Germany. Chief Warrant Officer Four Slade joined the U.S. Army National Guard in May 2016, as the Senior Legal Administrator, Joint Force Headquarters, North Little Rock, Arkansas. On 20 June 2016, she began serving as an Investigator with the National Guard Bureau Judge Advocate Office of Complex Administrative Investigations, Joint Base Andrews, Maryland.
