## **AMLA Veteran Scholarship**

The inaugural winner of the Association of Military Legal Administrators Veteran's Scholarship is awarded to Mashruf Ahmed, an Army combat veteran from Los Angeles, California. Mashruf served a little over three years in the Army as Human Intelligence Collector, Military Occupational Specialty, 35M, and he obtained the rank of Sergeant. He is a student of California State University where he is pursuing a degree in Public Administration.



In Mashruf's essay, he defined the pivotal moment in his life where he realized that advanced education was critical to his chosen career path was during the San Bernardino, California, shooting investigation for 2016. As a special agent with the

Federal Bureau of Investigation, he realized there was much he did not know about the intricacies of public administration outside of his own organization. It was that critical incident that he knew there is more that he could do, not only for himself but others inside his agency and partnering and local agencies as well—thereby benefiting the entire community.

For his efforts, Mashurf is awarded the first AMLA Veteran Scholarship. We hope that he is able to apply what he knows to Teach, Coach, Mentor, and Lead through Public Service.

## **AMLA Family Member Scholarship**

The inaugural winner of the AMLA Family Member Scholarship is Frank Stuyvesant. Frank is the spouse of Life Member Rebekah Stuyvesant. Frank is an Army Reserve Warrant Officer working towards a Master's degree in security management at American Military University.

Frank's decision to further his education comes from a

deep passion for military service. He realized he was disheartened by what he witnesses as declining discipline, and initiative of young Soldiers and a deterioration high standards of training from our noncommissioned officers. His call to action is to live by action, education, and reputation. He decided his education was what he needed to



work on, and he is making it happen.
