Call to Order

Social Purpose and Marketing. Director, *Andy Perkins*, we have received 300 AMLA silicone bracelets which we will begin marketing on the AMLA store. I also sent AMLA pins in the Run4Veterans packets for runners that are members. Samples should be prepared to be discussed in April.

Social Media. Committee Chair, *Alana Almon-Scott*, the Women's History Month videos are a huge success focusing on female Legal Administrators!

Unfinished Business.

Maybe we should look at three \$1000 scholarships. One will be a dependent of AMLA members. The others would be non-affiliated veterans. At this point, we have broken even on the Run4Veterans expenses—every other registration will be profit. A motion was proposed to authorize the scholarship committee to advertise one AMLA family member scholarship and two Veteran scholarships totaling \$1000 each. The motion was carried unanimously.

New Business

Planning AMLA Summer events including elections should be initiated. Based on COVID19 mitigation measures, we should suspend planning summer event except elections. There was discussion about a resolution to create a virtual Annual meeting of the members to be voted on in April. The current Board members all agreed to continue in their current position if reelected if necessary.
